



## 2011 INTERCOLLEGIATE SPORT REPORT

### GENERAL

---

2011 was an excellent year of intercollegiate sport from an administrative and competitive perspective. We were fortunate to have an enthusiastic and strong willed committee and a very supportive council who offered advice on the major issues that arose during the year. The committee, senior students & sports representatives were called upon to provide support convening each event, including the more staff-intensive events such as Rowing, Athletics & Swimming. The excellent leadership ensured safe, well managed events, with excellent spectator behavior and support from the sidelines. The enthusiasm throughout the college community for intercollegiate sport was certainly reflected and a great highlight of 2011.

The structures that had been put in place by SUSF and the Committee & Council allowed for a smooth transition when Leonie Lum was appointed Elite Athlete Program Manager, handing over day-to-day administration of intercollegiate sport to myself. I am grateful for Leonie's assistance, advice & support throughout 2011, and for the committee's hard work during this change of personnel.

Other than what is reported for each specific sport, the following adjustments were made this year in planning for 2012:

- Alterations to the Constitution in regards to the format of Rosebowl Rowing
- The removal of Rosebowl Softball to be replaced by Rosebowl Soccer
- A complete overhaul of the tennis by-laws to ensure the rules reflect a fair and reasonable interpretation

Overall, the level of competition between the colleges was extremely strong. Congratulations to St Andrew's College for winning both the Rawson & Rosebowl competitions. Rawson competition was particularly competitive, with each college winning or joint-winning at least 1 sport each. In the Rosebowl competition, St Andrew's College was victorious in 7 out of 8 sports, with their only loss coming in Softball – the last to be played in Rosebowl competition. Despite this, the margin of victory was often quite close.

Other than the Rawson & Rosebowl sports, a number of social sports were on the jam packed intercollegiate calendar. Women's Soccer was run in the manner befitting a Rosebowl event in preparation for its introduction to Rosebowl in 2012. Despite some early starts, participation was strong, and a 3 way tie between Andrews, Johns & Women's sets us up very nicely for next year. Intercol AFL was moved due to a clash with cricket season and the unavailability of the AFL club to run the competition, and then unfortunately cancelled due the unavailability of 2 colleges. This was a result of the competition falling during the Rawson Soccer competition, and the difficulty finding a suitable date when a clash existed.

The Rugby club were no longer able to run and support the Rugby 7's, so this was replaced by Intercol Touch Football which also incorporated International House & Mandelbaum House. This proved to be a successful and enjoyable evening, with intentions of running this again in 2012. International House sponsored and ran an Intercol Table Tennis competition in September. Intercol Twenty20 Cricket saw SUCC defeat the combined college's team, and the last event saw SUBxC host a successful Intercol Boxing night.

The year was rounded out with a successful Intercol Sports Dinner held at St Andrew's College. Apart from presenting the Rosebowl & Rawson Cups, the MVP of each sport was recognized, along with the Convenor, Sportsman and Sportswoman of the year. Jocie Gulliver (Women's College) was named the Convenor of the Year for Softball & Soccer; Bridget Burns (St John's College) was named Sportswoman of the Year; and Mike Power (St Andrew's College) was named Sportsman of the Year. Two other highlights of the evening were the Haggis ceremony and the interview with Stuart Clark, Australian cricketer. Both will be hard to top in following years. St Andrew's College were also presented with the combined Rawson/Rosebowl plate for winning both competitions in the same year, which they have done now the last 2 years.

#### Achievements in 2011

- The successful resolutions of issues that arose throughout the year by the committee & council, such as finding alternative dates for Rosebowl Tennis; the theft of riggers from St Andrews College; and spectator behavior at Rawson Cricket and Rosebowl Tennis.
- The overall level of verbal harassment via offensive sledging was minimal in 2011.
- The tribunal was not called upon in 2011.

#### Recommendations for 2012

- Ensure the dates allocated for social sports are cross checked with the relevant SUSF clubs well in advance of setting the Intercol calendar.
- Introduce the policies & procedures manual, as well as reinforcing the Intercol Code of Conduct
- Ensure each sporting event's by-laws are closely examined for any areas that would be open to interpretation, or are confusing.
- Cynergex have submitted a proposal to sponsor Intercol events by providing First Aid services at events in exchange for promotion of their logo in Intercol brochures and email correspondence.

#### Recommendations

- The appointment of umpires through New South Wales Cricket Umpires and Scorers Association continues to be a great benefit for the competitions. Umpire fees will also need to increase in 2012.
- Delegating score duties to the 12<sup>th</sup> men remains the most reliable system of ensuring that results are recorded and scorebooks returned following games.
- Boundary lines need to be set up by convenors for St. Paul's and St. Andrew's Ovals.

- Accurate recording of results and the checking of player eligibility requires team lists to be submitted to the convenor and/or SUSF prior to competition commencement.
- Ensure that the colleges play on a different day each week to avoid missing the same classes.

## **NETBALL**

*Tue 29 March, Fri 1, Mon 4-Wed 6 April – St. Andrew's College*

The 2011 Rosebowl Netball contest commenced on March 29<sup>th</sup> and ran through to Wed 6<sup>th</sup> April. The majority of matches went ahead unaffected, but we did have two logistical issues on the 3<sup>rd</sup> day. In the first game, it began to pour in the 3<sup>rd</sup> quarter, with both teams agreeing to continue. The second game however was washed out. In replaying the lost game the next day, the booking of the lights hadn't taken this into account, and the lights went off in the 1<sup>st</sup> quarter. After waiting for the lights to be turned back on, the game had to be reduced to 2 x 12 minute halves.

## **ROWING**

*Wed 4 May – Sydney International Regatta Centre*

Held in Penrith, the weather was excellent, and we had a handful of alcohol related incidents, but nothing too serious. First Aid & Security staff were on hand to ensure that everyone was well looked after and attended to. We received a cleaning bill from the Regatta centre for the paint that was left in the bathrooms. The use of an Aquatic Services Provider provided an extra element of safety, and the use of MCs brought

more atmosphere to the races. The use of the risk management procedure was successful, and the committee provided excellent support during the day.

There was an incident pre-event when the riggers were removed from St Andrew's college, which could have proven disastrous to running the regatta. Fortunately they were recovered, and didn't affect St Andrew's performance during the event.

*Results:*

The rain held off for a competitive regatta this year. Despite slight winds on the water, on the ground, the Intercol Committee, senior students and sports reps banded together to control the masses. The 2009 risk management guidelines were implemented again with success, resulting in a 100% return of bond.

- Staffing and officiating ratios are suitable with three boat race officials and the Intercol Committee assuming all officiating roles. The assistance of sports reps and senior students is essential for the supervision of spectators. SIRC continues to provide excellent facilities and staffing support through security and event convenors. Boat holders are up to the colleges to provide. Senior student supervision of boat minders is necessary as well.
- Use Cynergex instead of St John's Ambulance. The attitude of the St John's Ambulance staff was very negative.
- Gate opening times could be adjusted to opening at 7:30am and closing at 12:30pm. Spectators were not permitted to enter the venue until convenor and/or SUSF arrival at 7:30am. This should be implemented again in future years to prevent injury and damage.
- In 2012 we will need to communicate early the need for compulsory weigh ins.
- The Rosebowl will also revert to an 8 person 2000m race in 2012.

Held at Cintra, the competition and spectator behaviour was of high quality. There were no major injuries, with the main concern over the availability of referees who were called away last minute. A meeting & review followed in Semester 2 to discuss the best way to handle this situation as it caused disruption to both the colleges and rugby club. The final was a fantastic game and ended in a tie for 2011.

Soccer proved to be one of the closest fought events on the entire calendar, as all matches could have easily gone either way. While the Rawson competition ran very smoothly, with excellent weather and no issues in regards to rulings or fixtures, the Rosebowl competition faced a number of issues. These stemmed from the 3.5 days lost to wet weather which required a number of fixtures to be completed over 3 different wet weather dates. In planning for these rescheduled matches, it became apparent that the Tennis by-laws did not provide good direction as to what was to be done. This created a lot of confusion amongst the teams, and in order to finish the competition, not all players were able to compete. While not an ideal situation, the college committee and captains worked well to find an amicable result, and have put measures in place to ensure these issues will not arise again. Clarification has been made re: the rankings system, as well as what to do should a match be washed out. There was also the unfortunate incident of verbal abuse during Rosebowl which was responded to by the committee immediately.

- Make clear in the by-laws how each quarter is timed (8 minutes fully timed – clock stops when whistle is blown; in the last 2 minutes of the last quarter, the clock stops after every basket scored)
- Remind volunteers about their roles early
- Have someone assigned to court sweeping between quarters.

The final event of 2011 was held at Sydney Olympic Park, with another successful event convened by Leonie and a number of college volunteers. The only issues were

one major injury to a Wesley athlete, as well as some disqualifications in the relay races. The running event was assisted by having portable radios for the volunteers but this took on a greater expense than budgeted. We also had to pay for an extra official after some miscommunication from Athletics NSW. However, on assessment we may require an additional jump & throw referee in 2012, or allow for greater time between events in the schedule.

- Don't forget signage & rules, including measuring tape & permanent markers for marking runners in long distance races.
- Make clear the distinction between A & B point scoring.
