



## Sydney Uni Sports Camps - Enrolment Terms and Conditions

1. By enrolling your child/ren into a Sports Camp/s, you acknowledge that you have read and agree to the terms and conditions outlined.
2. Payment must be made in full at the time of registration in order to secure a booking. You will receive via e-mail, details of the camps.
3. If enrolment is cancelled more than 10 business days prior to the start of camp, you will receive a refund of payments less \$50.00 administration fee.
4. If enrolment is cancelled less than 10 business days prior to the start of camp, the camp fee is non refundable.
5. If enrolment is cancelled for medical reasons, you will be provided with a credit note if validated with a medical certificate. No cash refunds will be given.
6. If you would like to change camps a \$10 administration fee will be charged
7. A \$2.75 transaction fee will apply to phone and online bookings
8. Camps and transport are subject to cancellation, alteration and rearrangement in the event of unsuitable weather conditions or other factors which may arise that are beyond the control of Sydney Uni Sport & Fitness (SUSF).
9. SUSF reserves the right to refuse or terminate enrolment if there is a breach of the Camp Behaviour Policy (available on request).
10. By enrolling your child/ren in a camp, you accept that they may leave the premises to partake in off-site activities where this has been advertised or where the venue is unsuitable and there is an adjacent/secure property.
11. Children not collected 15 minutes after the conclusion of the camp (3:30pm) will be booked into Aftercare, resulting in an immediate \$25 Fee payable at HK Ward reception upon collection of your child.
12. At the conclusion of Aftercare (5:30pm) if your child/ren have still not been collected an additional fee of \$10 per child per 15 minutes after 5:30pm will be charged i.e. If collected from 5:30pm – 5:45pm additional \$10, if collected 5:45pm – 6:00pm additional \$20 and so on. This additional fee is payable at HK Ward reception upon collection of your child.
13. SUSF do not accept any liability for personal injury, property damage or loss sustained by any participant as a result of his or her participation in a camp due to any cause whatsoever unless caused by the proven negligence of SUSF, its directors or employees.
14. By enrolling your child/ren, you authorise SUSF staff to use for publicity and advertising purposes, photographs of participants taken at camp.
15. By enrolling your child/ren, you authorise SUSF staff to obtain such medical assistance as they see fit and you also agree to meet the expenses attached thereof.
16. By enrolling your child/ren, you authorise SUSF to retain enrolment information on a confidential database, which shall be removed if requested.
17. If utilising the SUSF Member Discount: Failure to produce membership number at time of enrolment will result in the full charge being applied.
