# 2014 INTERCOLLEGIATE SPORT REPORT 

## GENERAL

In 2014 the Intercol Committee and community faced some significant challenges throughout 2014, particularly during Rawson events and due to poor spectator behaviour. Incidents of a 'serious' nature occurring at the following Rawson events: cricket, swimming, soccer, rugby and basketball. See notes at individual sport reports below. The operation of each event has been successful, with no major administrative issue experienced on the various match days. This can be largely attributed to the work of the Committee, the sports reps and relevant captains.

The overall level of competition between the colleges remains strong. Congratulations must go to St. Andrew's College for winning both the Rawson and Rosebowl competitions for the fifth year in a row.

Other than the Rawson and Rosebowl sports, a number of social sports are included in the official sporting calendar. Touch Football made a return this year and the annual Sydney Uni Cricket Club (SUCC) XI v Intercol XI Twenty/20 Cricket match will be played over the coming weeks. Unfortunately AFL was cancelled due to wet weather.

The year will be rounded out with the Intercol Sports Dinner held at Sancta Sophia College on the $24^{\text {th }}$ October 2014.

Operational changes made to College sporting events in 2014:

- Appropriate First Aid coverage provided at ALL high impact events.
- Ban on megaphones at all events during 2014.
- Alcohol ban for events being held on St Paul's College during 2014.
- Sport marshals/representatives asked to be present at each event for monitoring and disciplining spectator behaviour at events alongside the SUSF delegate. Results varied - mostly successful.
- Each competitor to complete a Code of Conduct declaration form and hand to SUSF delegate prior to participating in each event.
- Spectator barrier moved during Rosebowl netball at St Andrew's college netball court to reduce impact of spectator banter and for spectator safety.
- Final round of netball played in SUSF facility after bad weather forced the round to be rescheduled several times.
- Police presence declared unnecessary for Intercol Rowing at SIRC for future events due to continued good behaviour at venue.
- Spectators moved to Grandstand during Rawson Rugby - successful and ensured player and spectator safety.
- Intercol Tennis moved from Lawn tennis courts to SUSF Sports \& Aquatic Centre courts due to continuous wet weather.
- Continued with the recommendation of fines on individuals and colleges for breaches of the Alcohol Policy or code of conduct at Intercol events.
- Increased promotion of and opportunities for social and participation focused sporting events - including lunchtime social sport participation.


## Recommendations for 2015:

- Revise Intercol Constitution and disciplinary procedures for 2015.
- Review and revise Sporting Code of Conduct for 2015.
- Intercol Committee induction and training as well as structured handover from previous Committee members.
- College Sports Representatives (sport secretaries) to form their own Committee and to meet on a regular basis to discuss upcoming sporting events and to report back to Intercol Committee regarding issues, modifications and strategies to ensure player and spectator safety.
- Calendar 2015 - limit or change events due to be held on Wednesday evenings. Heightened risk of alcohol consumption and inebriated spectators being present.
- Soccer to be played at new SUSF facility (currently Oval 2) and spectators to remain in grandstand. To be confirmed by SUSF upon venue completion.
- Security to be organised for Intercol Rugby, Soccer (if held in new grandstand), Basketball and Tennis - bag checks for ALL students upon arrival and no drinks to be brought into SUSF facilities.
- Cleaning costs to be passed on to College students' clubs for SUSF facilities.
- Basketball to be played earlier in Semester 2 - swapping tennis and basketball order around in 2015. Constant issue with Flames training and availability of SUSAC facility.
- Senior students and or College staff to remain on-site throughout the duration of each College game/ event.
- Megaphone and alcohol ban to remain in place for 2015.
- Continue with requirement of competitors to read and acknowledge the SUSF and Intercol Codes of Conduct prior to participating.
- College residents ONLY to spectate at college events (unless in organised College events and discussed with SUSF delegate).
- 'Better banter' document adopted by all Colleges and considered integral to cultural change and improved behaviour.
